Terms and Conditions of stay

Guests: If you are booking on the behalf of others please ensure that they receive a copy of the terms and conditions. All occupants should be fully aware of the details and conditions of their stay. The Number of Guests must not exceed the number stated on the Confirmation Notice or subsequently agreed in writing or email. Fees will apply for excess guests not agreed with the owners in advance.

Parties and Functions are strictly prohibited. The price charged is for domestic use only and not commercial.

Accordingly this rate does not allow for the extra wear associated with functions in terms of cleaning, garbage removal, wear and tear, repairs etc. Use contrary to this may result in loss of your bond and/or additional payments..

Minimum Stay: We do not book the Homestead for stays of less than two nights.

Tariff: Homestead tariff is \$450/night (\$500/night during School and Public Holidays). The Homestead sleeps up to 5 persons. A Studio is also available that sleeps up to an additional 7 persons for an additional tariff of \$200/night. Tariffs are subject to change and will be confirmed at time of booking.

Payment: Payment can be made by credit card or direct deposit. A deposit of minimum one night's accommodation fees must be paid to ensure your booking. Payment in full must be paid prior to arrival date. You will be required to leave credit card details as a bond against damages and breakages.

Check-in and key arrangements: Check-in is after 2pm, although there is no strict check-in process. Heading straight up to the Homestead is agreeable. There is a lock box located at the front door of the homestead and a code will be supplied before you check in to access keys.

Departure time: 10am is the latest departure time unless prior arrangements have been made. If the departure is after 2pm then another day's tariff would be required.

Cancellations and early departures: Deposits are non refundable unless a minimum of two weeks notice is received. Early departures, unless notified two weeks prior, will be charged for the full stay.

Departure: We ask that the property is presented to us as clean and tidy as possible when you depart. If the Homestead is not left in an acceptable condition, cleaning will be charged to your credit card at a rate of \$45.00 per hour. If carpets, rugs or furniture are soiled there will be a cleaning charge also applied to your credit card.

Smoking: The Homestead is a smoke free environment. If smoking outside please use sand pots provided to extinguish all butts.

Cleaning and servicing: The property is not cleaned or serviced during your stay. Cleaning equipment is provided but if you wish the property cleaned, this can be arranged at a cost of \$45.00 per hour.

Luggage: As we do not have a physical reception, we are not able to store luggage for you prior to your check-in time or after you check-out.

Pets: A maximum of two pets are allowed at the Homestead at any time. This will incur a pet bond of \$250.00. Pets are not to go on any carpeted areas or on any furniture and any damages or additional cleaning will have to be paid for.

Repairs and condition of the Homestead: We will endeavor to ensure of all appliances etc in the Homestead are working properly. If you notify us of a faulty appliance, that the Homestead is not spotlessly clean, or if something is wrong with the Homestead, we will take steps to have the fault corrected as soon as possible.
